a. Superintendent's Report – Walker reported on enrollment numbers for the 23-24

school year as well as new hires for the 23-24 school year. The transition to Partner Solutions has gone very smoothly. The Festival of Athletics went well, and Walker thanked TCAPS for allowing us to use their facilities as well as the staff and parents that helped to make it happen. The high school is beginning to receive technology and furniture. The expansion grant is coming to a close for Implementation II and the June report has been submitted. NHS ceremony took place as well as a Robotics end-of-year celebration. CTC and NMC are high-interest areas. GHS is offering summer school for the first time. The fire panel and Maple windows have been replaced as well as the locker room door glass. Air purifiers have been purchased for all rooms at the middle school. The 6th, 7th, and 8th Grade Trips all went well. The plant sale raised about \$800 for the outdoor program.

- b. President's Report Babin-Ringsmuth submitted a report to the board folder and thanked Tara Ward for serving the board for the past 10 years. She also thanked Robert for his commitment to the school over the past 3 years.
- c. Treasurer's Report Walker reported an update on the financial report. He also noted that an online curriculum may be added to the budget similarly to how rent is, as a temporary debt.
 - i. CSP Grant Walker stated the report was filed on June 15 and we are able to receive the full amount. The deadline for spending the Implementation II grant is approaching.
- d. Authorizer's Report GVSU's representative, Matt Missias, reported Don Cooper will be leaving as well as Alyson Murphy. Rob Kimbell will serve as interim. For the School Performance Report, the academy description and highlights will be accepted soon. GVSU is hosting many summer webinars. National Constitution Council is accepting submissions, and on June 29, GVSU is hosting: Best Board Practices. The board has fulfilled all requirements for this year. Currently, we are still expecting an increase in the school budget. Missias thanked Robert for all of his work over the past three years and also thanked Tara for all she has added to the board over the past 10 years.
