Desiree reported Bloomerang is very easy to use and the costs are upfront including tech support. Typical return on investment is 8 months to a year but it is up to the organization and how effectively they incorporate the tool. Kuhn expressed that it is helpful to create a

marketing plan before utilizing the marketing software. Cabrera and Babin-Ringsmuth discussed the need to get this started soon and voted on it tonight.
