## VIII. Reports

- a. Superintendent's Report Schramm reported 103 applications with 14 new students at the high school and 60 middle school applications with 21 new students.
- b. President's Report The report is in the board packet. Constanza Hazelwood will not be renewing her term on the board in June.

- c. Treasurer's Report Pardo included the report in the board packet. We currently meet the state minimum for the fund balance. Expenditures are doing well overall.
- d. Authorizer's Report GVSU's representative, Matt Missias, reported that the Spring Leader's Retreat in Traverse City is on May 17 and 18 with a social hour on May 16. A survey from GVSU Charter School is being sent out on February 28th for teachers. The board members survey is open until February 28. The Board Reception will be held on May 14 in Grand Rapids. The GVSU photo contest is live and submissions are due March 31. Any graduate of a GVSU charter school is eligible for a \$1,000 scholarship. The Core Values award is focused on integrity with a prize of \$5000. Greenspire was awarded \$5,347.50 in the Academic Grant. School Performance Report for High School is averaging about 70 points below peer schools on the SAT. Peer schools have been realigned to fit the school better than in previous years. Middle School is low in math but taking the right steps to correct that. Middle School has made large gains overall, especially in math.
- e. Faculty Summary Phil Girard highlighted that Fake-A-Day had 24 students at the middle school which is one of our biggest Fake-A-Day events on record. There are ongoing concerns with staff retention. We have the Beauty and the Beast Jr performance coming up and need help getting the word out.
